Remarks for Service Termination / Suspension / Resumption 終止/暫停/重開服務附註：

1. If the period of suspension exceeds 6 months, Realink Financial Information Limited is entitled to cancel the subscriber's paging number (P.C.N.) or login name without giving any prior notice or compensation to the subscriber.

2. For any request for suspension of service for less than 7 days, or any request for suspension made within 7 days of service resumption, a handling fee of HK\$100 will be charged.
